Consent And Legitimate Interest.

Data must be processed by us using one of the legal valid bases defined by the regulation, summarised in the table below.

Consent

Individuals Rights

Right to be informed – When we accumulate your data, we must inform you what are we going to make out with it primarily through this privacy policy and consent statement.

Right to access – You own the right to reach us in writing to request details of the data we have about you.

Right to Rectification – You have the right to ask us to rectify the information that we hold about you if it's inaccurate or incorrect.

Right to erasure – This is also known as "the right to be forgotten". This gives you right to request your information to be removed/erasure verbally or in writing.
